- 1. I am currently a doctoral candidate at the North-West University in South Africa. The registered title of my thesis is "The AU/UN hybrid peace operation in Africa – a new approach to maintain international peace and security" (please see attached a copy of my research proposal). This study will primarily be a case study of UNAMID to determine whether or not the United Nations has deviated from regular peacekeeping practice by participating in a hybrid peace operation and to test the implications for the United Nations by being associated with a hybrid operation.
- 2. As part of my research, it will be necessary to conduct interviews with staff members who have been or are still involved with UNAMID. My studies do not focus on operational aspects of UNAMID, but rather on the political dimension of the hybrid operation.
